NCCU School of Law received over 3,200 applications and matriculated 172 Day Program students and 34 Evening Program students for the year of 2010! Our Student to Faculty ratio is 17:1. North Carolina Central University School of Law was ranked #1 in the nation for the best value for two years in a row, according to The National Jurist and preLaw magazines' Best Value Law Schools report. The magazines' rating system was based on three factors: the law school's affordable annual tuition, 86% bar-passage rate and employment rate of 87% within nine months after graduation. The Law School offers two programs leading to the Juris Doctor degree: a full-time Day Program and the only fully ABA accredited part-time Evening Program between Atlanta, GA and Washington DC. CLINICS and INSTITUTES

NCCU School of Law was selected for the US Patent and Trademark Office Clinic Program and was ranked 20th in the nation by National Jurist Magazine. Currently the School of Law offers 14 clinical programs and two Institutes. They are: ADR, Civil Litigation, Criminal Defense, Criminal Litigation, Criminal Prosecution, Family Law, Juvenile Law, Veteran Law, Small Business, Domestic Violence, Pro Bono, Street Law, Center for Child and Family Health Judicial Externship Program, General Externship Program I and II, Dispute Resolution Institute, and the Biotechnology and Pharmaceutical Law Institute; making it the most comprehensive program of any law school in the state.
